- 3. The Tender and any order resulting from this Tender shall be governed by our conditions of contract and the supplier quoting against this Tender shall be deemed to have read understood the same.

4. Where Counter Terms and Conditions of business have been offered by the supplier shall

not be deemed to be governed by those unless our specific written acceptance thereof has

been given. Special conditions, if any, printed on the quotation sheets of the tenderer or

attached with the tender will not be applicable to the contract unless they are expressly

accepted in writing by the purchases. No Conditions and Terms, notice of which has not

been given by the Supplier while submitting tenders, will be considered by us, if put

forward in subsequent correspondence.

5. **Security Deposit:-** Acceptance of the quotation constitutes a concluded contract.

country of origin/supply or delivery during the course of execution of the contract.
